

### **Litigation and Insolvency**

We regularly appear in all levels of the judiciary, from Magistrates' Court to the Court of Appeal (which is Bermuda's highest appellate Court).

While litigation may be necessary in some cases, we take the time to understand your needs and endeavor to resolve your case by the most efficient means possible. In appropriate cases, our lawyers can advise on the various alternative dispute resolution methods, such as arbitration. In addition, our lawyers can be instructed to make applications to the Supreme Court for interim injunctions on an urgent basis. We understand that litigation can often be stressful, so we do all we can to handle each case as expeditiously and efficiently as possible while always remaining strategic in order to obtain a desirable outcome.

### ***Commercial Dispute Resolution***

Commercial disputes often span a myriad of legal areas and consequently raise a number of complex issues. Our Team acts in all areas of business disputes and has the benefit of working alongside our specialist Corporate Department whenever necessary. Our commercial practice includes litigation arising out of the Companies Act, shareholder disputes, partnership disputes, professional negligence, shipping law, contractual disputes and interpretation, conflict of laws, civil fraud, banking and finance, telecommunications and interim injunctions.

### ***Insolvency and Restructuring***

Our insolvency practice is both international and domestic and includes making and defending winding-up petitions, advising creditors and liquidators, and advising on matters of priority, locus standi, and procedure.
